Chief Henry stated our latest firefighter academy class of eight graduated on the 15th. He called the District Board's attention to the attached picture and bios of each of the Academy Graduates.

C) CDBG Grant Update

Chief Henry updated the District Board the District has been rated number two on the grant award list for the CDBG grant the District applied for to purchase a Type Three Fire Engine for Station 57. The grant process is still moving through the final stages but as soon as the District is notified on the outcome. I will bring you an update.

7. WEED ABATEMENT CONTRACTOR AGREEMENT.

A) Action item – Consider and approve agreement with Sequoia Western for weed abatement services.

Mr. Barcelos stated the District's weed abatement agreement with Sequoia Western for abatement services needs to be renewed for the current weed abatement season. Staff has contacted Rick Ferdinandsen with Sequoia Western and he has agreed to perform the District abatement services with a proposed rate increase. Mr. Ferdinandsen has provided abatement services for the District for many years at the same rate. The rate he is increasing is the minimum time billed which he is increasing from \$120 to \$135, and the rate for work performed in excess of the minimum when two or more men are working is increasing from \$110 to \$125. All other rates are remaining the same.

Mr. Barcelos answered a couple questions from the District Board and after the discussion, Mr. Abrahamian called for a motion.

8. TYPE VI FIRE ENGINE FROM CAL OES

A) Action item – Authorize Fire Chief Henry to sign agreement with Cal OES for District to use a Type VI OES Fire Engine this fire season.

Chief Henry stated last year I let the board know I was going to submit a letter to California Office of Emergency Services Fire and Rescue Division (OES) letting them know we would be willing for the district to host one of their fire apparatus here in the district. About six months ago I received a phone call that our district did come up on their list and they asked if we were still interested in receiving one of the OES engines. I advised OES staff at the time that the District was still interested so the District recently received a notice OES is ready to send us an agreement for the use of an OES engine.

Chief Henry stated for Board Members not familiar with OES engines, the State of California has multiple types of engines they loan out to fire departments throughout the state during fire season. OES has type one engines which are like the engines the District currently deploy out of our fire stations, OES has type three which is like the engine we are applying for through the CDBG grant and has Patrol Units geared more to vegetation and wildland. The State OES Fire and Rescue Division has more fire apparatus than the majority of all fire departments in the state of California.

During wildland season OES will strategically deploy some of their fire engines throughout the State to fire agencies willing to host an engine so OES can use

them during wildland season. The advantage to the agency hosting the engine is that the agency can use the engine in their own operations. While a District is hosting an OES engine, the District is required to staff the vehicle for the state when called to help with a wildland fire within the State. The State will reimburse the District for the personnel we send on a state fire just like they do now but we will be using the engine OES loaned the District.

Chief Henry answered a few questions from the District Board to further explain the process and ways the District can use an engine from OES and where it will be housed. After the questions and discussion, Mr. Abrahamian called for a motion.

Motion: To authorize Fire Chief Henry to sign agreement with Cal OES for the District to host a Type VI OES Fire Engine this fire season.

Chief Golden added my staff has always applauded the performance of the District personnel, the City staff has nothing but praise when they deal with the fire District. When the City has questions, the District is well placed to be a sounding board and a good source of advisement on large scale operations and operations that cross geographic boundaries because of its relationship with the County, the City of Fresno and State resources. I am especially pleased with the advice and support Chief Henry and staff gives the City on opportunities we have on grant processes. I just wanted to take this opportunity to applaud Chief Henry's performance and the leadership that is obvious from the performance of his staff, the gracious hosting of our questions, and the District's work and dedicated partnerships with all things Kerman from the school district to public safety and services.

Mr. Abrahamian reported he and Mr. Nonini sit on the Ad Hoc Committee to review the proposal to renew the Metro Service Agreement the District has with the City of Fresno. Chief Henry has had dialogue with Chief Donis for the past few months and I would like to summarize what he presented to the Ad Hoc Committee. Initially the District submitted a proposal of \$1,098,462 for the first year, \$1,131,416 the second year, and \$1,165,358 in the third year which is a three percent cost of living adjustment increase annually. The City rejected the District's proposal and submitted a proposal for 2.075 million the first year, 2.138 million the second year and 2.202 million the third year.

Mr. Abrahamian stated, at this time, the Committee is recommending the Fire Chief bring back at the next District Board meeting the long-term budgetary impact

and the sustainability of the City's proposal. There are still some questions about what we are looking at long term with regards to the budget, can we sustain this proposal, and where will the District be. Mr. Abrahamian stated, I think by the May meeting, the District Board needs to make a decision and inform all parties of our decision. This is the Committees recommendation.

SUBJECT: Weed Abatement Public Hearing and Notices

The first public hearing for the weed abatement season is scheduled for tonight.

District engine companies began inspecting properties and areas in the District repeatedly in violation of the District abatement program on May 1st. During the inspections, several more lots in the District were discovered that need abatement. Of the lots inspected and discovered during the inspections, 123 were not abated and received a "Notice to Destroy Weeds." The notices were mailed to property owners on May 6th through the 10th.

After the public hearing being held tonight, engine companies will begin to re-inspect the lots receiving notices. Lots not abated will be assigned to the District's abatement contractor to abate, and the charges will be added to the tax roll by resolution adopted by the Board in July.

Attached is a list of the properties receiving the "Notice to Destroy Weeds" for review by the Board.

SUBJECT: Resolution No. 21-05 to amend the 2020-2021 Amended Final Budget

The District's 2020-2021 Final Budget needs to be amended to increase several operating expense line items that are over budget due to unforeseen expenses when the final budget was adopted in August of 2020.

There are four line items that need to be amended. Turnout, Training, Other Professional Expenses and Utilities. Turnout, Training and some of Other Professional Services need to be increased due to the District receiving the SAFER grant award to add twelve (12) additional firefighter positions. When the District adopted the final budget last August, the District had not received notification of the SAFER Grant award. The increase in Turnout and Training is to purchase turnout for the twelve (12) new positions and conduct the Training Academies. The hiring of the SAFER positions also increased Other Professional Services in the costs of physicals and background checks.

Other Professional Services needs to be increased for a couple other expenses incurred throughout the fiscal year. The District hired the consulting firm Lexipol to review the District's policies and make necessary updates. Another expense incurred in Other Professional Services is the cost to scan old records per the District's Records Retention Policy.

The expense for utilities is going to be over budget because of some delays in having the District solar panel inverters repaired. District staff noticed that some of the inverters at Stations 57 and 55 were not working properly. The repairs took three to four months because of the shortage of needed parts due to the COVID pandemic. The parts are under warranty but the delay caused the panels to not work as efficiently creating higher than normal electrical costs to the District.

THE BOARD OF DIRECTORS (the "Board") OF THE NORTH CENTRAL FIRE PROTECTION DISTRICT (the "District") RESOLVES, FINDS, AND DETERMINES AS FOLLOWS:

That the Operating Expenditures for Turnout, Training, Other Professional Services and Utilities be increased. Turnout, Training and a portion of Other Professional Services need to be increased due to the hiring of additional Suppression staff to fill vacancies and the twelve (12) SAFER grant positions. Other Professional Services needs to be increased for consultant services provided by Lexipol to review and recommend amendments to District policies, and for services provided to scan old District records per the District's Records Retention Policy. Utilities need to be increased due to delayed repairs needed on the District solar panel inverters which caused above projected increases in electric utility costs.

SUBJECT: Long-Term Budgetary Impact – City of Fresno Service Agreement

Background and Summary

The District currently has a three (3) year service agreement with the City of Fresno to provide services in the District's Metro area that surrounds District station 59 in the Bullard and West area. This current service agreement expires June 30, 2022. On October 20, 2020, Chief Henry, on behalf of the District, submitted a proposal to Chief Donis, with the City of Fresno. The proposal included a three (3) year extension of the current service agreement that would increase the first payment to the City by three percent and continue with an annual three percent increase. The initial payment proposed by the District was \$1,098,462 which is a three percent increase from the final payment of the current agreement and would increase three percent each year.

Fresno City Fire Department, Fire Chief Kerri Donis responded to the proposal on October 23, 2020 by email, indicating that the current Auto Aid area should be a separate agreement and that the City of Fresno believes that the City's depth of response and standby time in the Metro Area is worth far more than \$1.1 million dollars annually. Chief Donis responded on January 8, 2021 with a counterproposal with an initial annual payment of \$2,075,731 with a three percent increase in the payment each year. The formula used by the City of Fresno was their annual budget of \$72 million dollars, with a City population of 540,000. Calculating the per capita cost at \$133/ City resident within the City. The City's counter proposal used a population within the North Central Metro area of 15,607, multiplied by their cost per citizen of \$133.00 equaling \$2,075,731.

District Board Chair appointed an Ad Hoc Committee to review this proposal from the City of Fresno and met with Chief Henry to gather information about the proposal to report their findings to the District Board at their April 22, 2021 board meeting. At the April 22nd meeting, the Ad Hoc Committee requested staff to provide the District's Board of Directors

at the May 20, 2021 meeting, a report showing the budgetary impact and sustainability of the City of Fresno's Service Agreement Proposal over a ten-year period.

Budgetary Impact and Sustainability Report

Attachment 10.1 is a spreadsheet showing the budgetary impact over a ten-year period starting in the 2022-2023 fiscal year which begins July 1, 2022. The spreadsheet has two parts, the top section is a ten-year look at the budgetary impact and sustainability of the District's finances if the District chose to accept the City of Fresno's proposal. The bottom section is the budgetary impact and sustainability if the District does not accept the City of Fresno's proposal but instead staffs District Station 59.

Looking at the Annual District costs in the top section budgetary impact report:

- ➤ Salary and benefits full staffing is the costs to fully staff the department at the staffing levels we are currently at which is sixty-four (64) personnel.
- > The next line which is services and supplies (operational costs) is basically all other costs not included in salary and benefits.
- The next line is the City of Fresno's proposal to provide services for the District in the Metro Area of the District.

In this spreadsheet, all these costs are increased each year by a three percent COLA increase all ten years.

- ➤ The next line is an annual contribution of \$900,000 into the District's Capital fund to set aside funds to make capital purchases and capital improvements.
- ➤ The next line is a reimbursement the District is projecting for the 2019 SAFER grant awarded to the District. The District will receive a full year's worth of grant funding for all of the 2022-2023 fiscal year and eight and a half months of grant funding in the 2023-2024 fiscal year.

Revenue:

➤ This line shows the total operating revenue projected for each fiscal year with a three percent projected increase in revenue each year. Currently the District has experienced a six-year average of 5.39 percent increase in revenue, so the three percent is a conservative projection.

Net Revenue (Bottom Line):

As you can see the results of the annual net revenue for all ten years is a loss in net revenue or in other words, the costs exceed revenues even in the years the District receives SAFER Grant funds.

Moving to the bottom section of the budgetary impact report:

➤ The first two lines, salary and benefits – full staffing and services and supplies (operational costs) are the same as on the top section of the report. The salary and benefits show the current staffing level which will continue and additional staffing for station 59 is reflected on the third line in this section.

- The third line is the costs of adding staffing to help staff District station 59.
- > The fourth line is the annual contribution made to the Capital fund.
- > The last line in costs shows the SAFER grant funds the District projects to receive.

In this spreadsheet, all these costs are increased each year by a three percent COLA increase all ten years.

Revenue:

District revenue is the same projected in the top section with a three percent annual increase.

Net Revenue (Bottom Line):

Net revenue in this scenario exceeds costs in all ten years. The first two years the District is still receiving SAFER grant funds but even over time, revenues exceed costs.

Operational Impact:

The current Service Agreement with the City of Fresno provides limited fire suppression coverage in the NCFPD Metro zone. This zone is 5.2 square miles (within ten Fresno County islands created by annexations) and is situated between highways 99 and 41, south of the San Joaquin River and Dakota Ave. The District islands are bordered by the City of Fresno and Fig Garden Fire Protection District. In 1953, the District built and operated a fire station at 1709 W Bullard Ave., Fresno CA. The Metro zone was contracted out for service in January of 2007. The fire station continued to house a Fresno County contract Advance Life Support (ALS) ambulance for more than a decade. It was also used as a temporary fire station by the City of Fresno during the remodel of their fire station #2.

If the Board gives direction to re-open Fire Station 59, there is no assumption that the City will execute an instant/automatic aid agreement with the District that is materially similar to other such agreements entered into between the City and other fire protection districts or agencies. The City has declined thus far to discuss or inter into a true Automatic Aid agreement as defined in the OES Fresno County Operational Plan. If the District and City participated in an Automatic Aid agreement, there would be a notable level of benefit to both agencies. A three (3) year analysis of Fresno City incidents within 4-minute response of Station 59 totaled 7,581. There were 145 structure fires within the 4-minute response time. There were 2,568 City incidents where North Central Station 59 would have been closer than a Fresno fire station.

The Metro zone averages 650 emergency calls for fire service annually. Fire incidents account for 4% of those calls for service. Less than 1% are structure fires (6/yr) annually and only 50% of those required more than one fire engine to contain the fire.

The above budgetary proposal to re-open Station 59 includes 2 fire apparatus with 6 full-time fire suppression personnel assigned daily. This will allow the District to provide a 4-minute response time 98% of the time, and meeting the Cal-OSHA standard for 2in/2out for interior suppression efforts.

Attachment 10.2 "Response Area" demonstrates that 98% of the Metro zone residents are within 4 minutes of Fire Station 59 and 100% are within the ISO standard of 5 miles from a fire station.

Attachment 10.4 "FY2020-2021 Metro Service Agreement Incident Summary". This document has the first 10 months of the fiscal year. The monthly incident count is consistent with FY2019-2020.

Recommended Action: Authorize District Board Chair to notify the City of Fresno in writing of the decision to not renew the Service Agreement for the Metro Area with the City of Fresno after it expires on June 30, 2022.

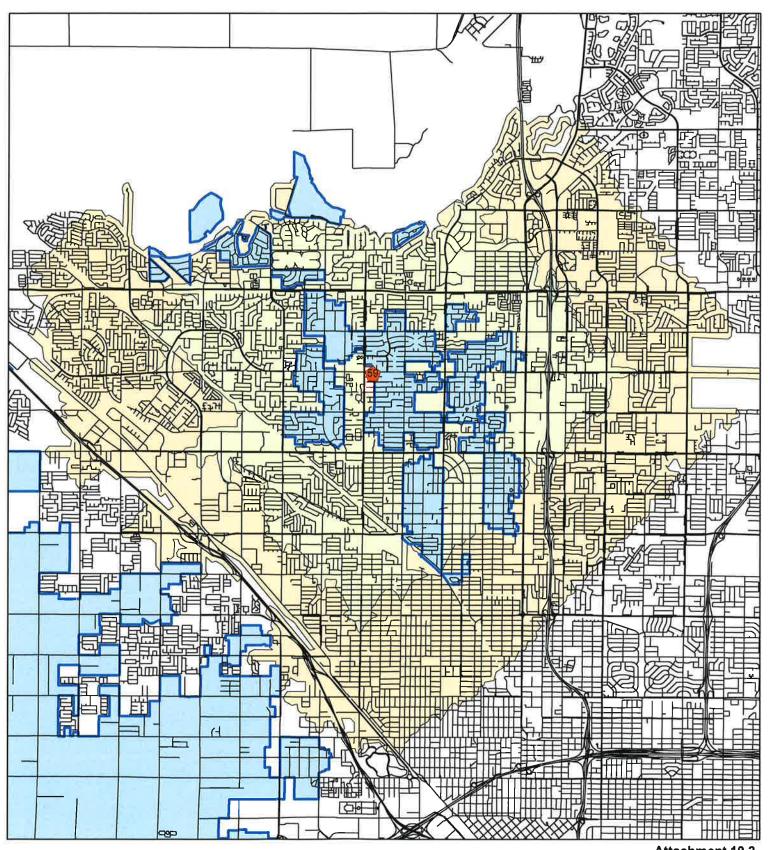

NC Metro Response Areas



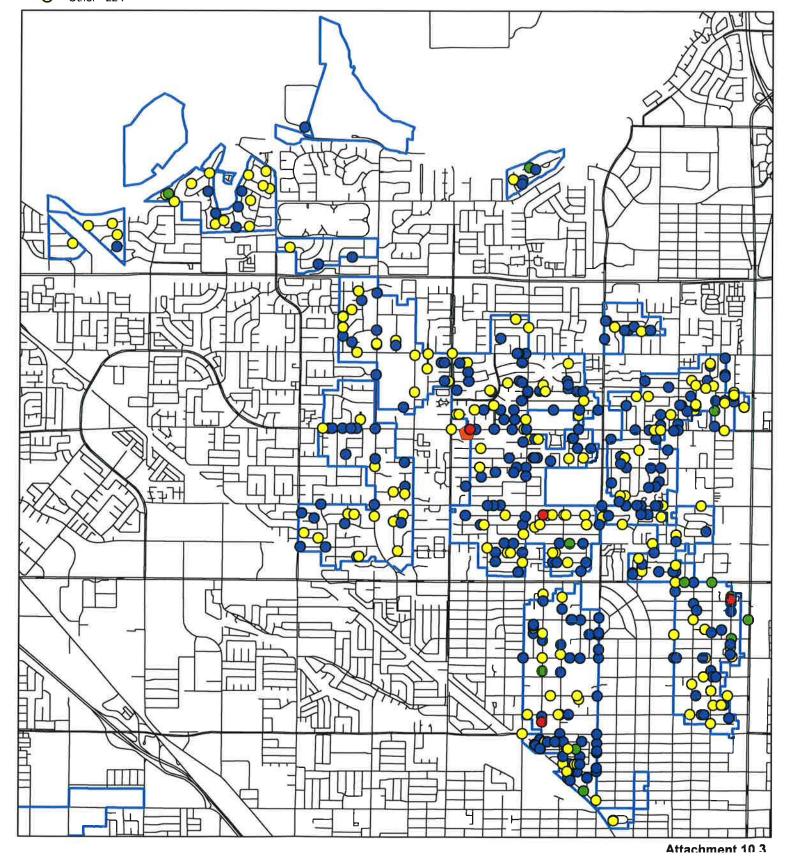


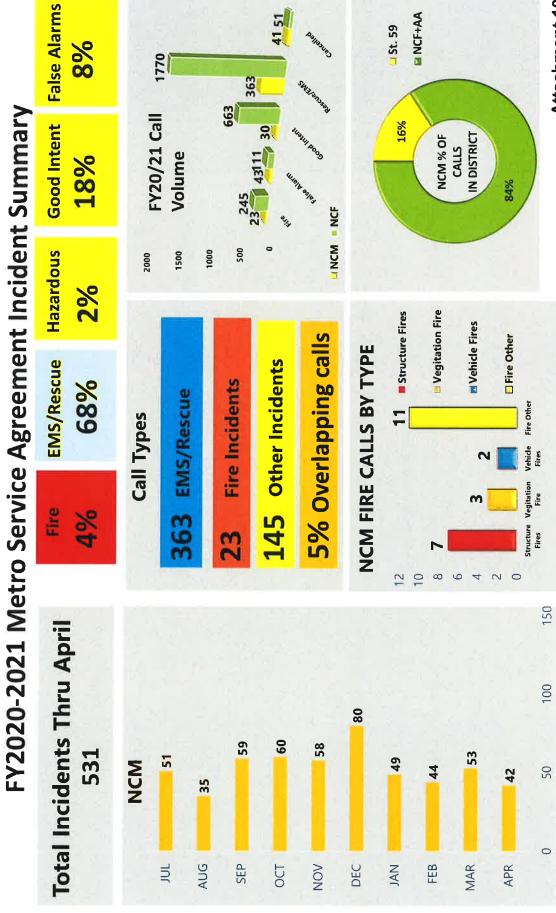
NC Metro Area All Incident Types
