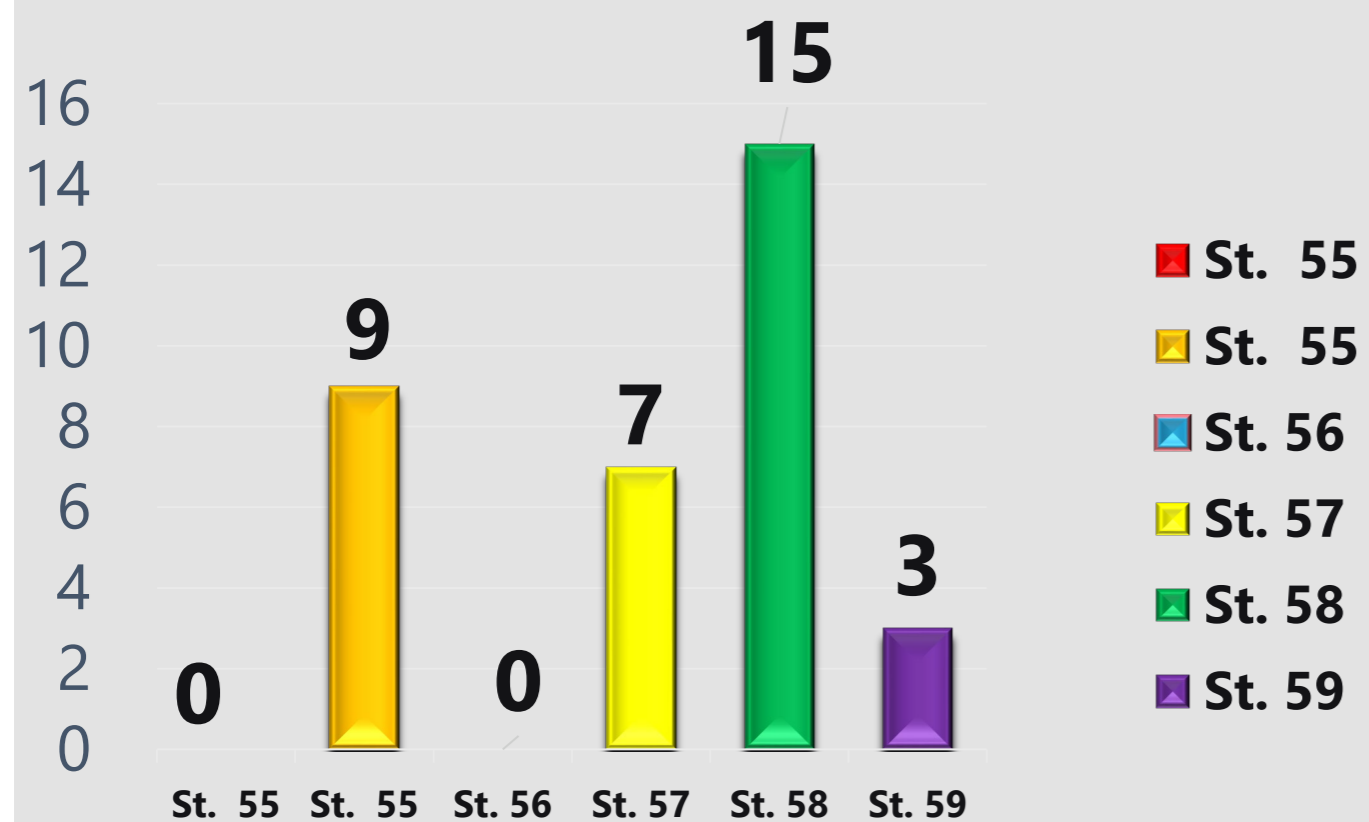
## Average Response Time Fires



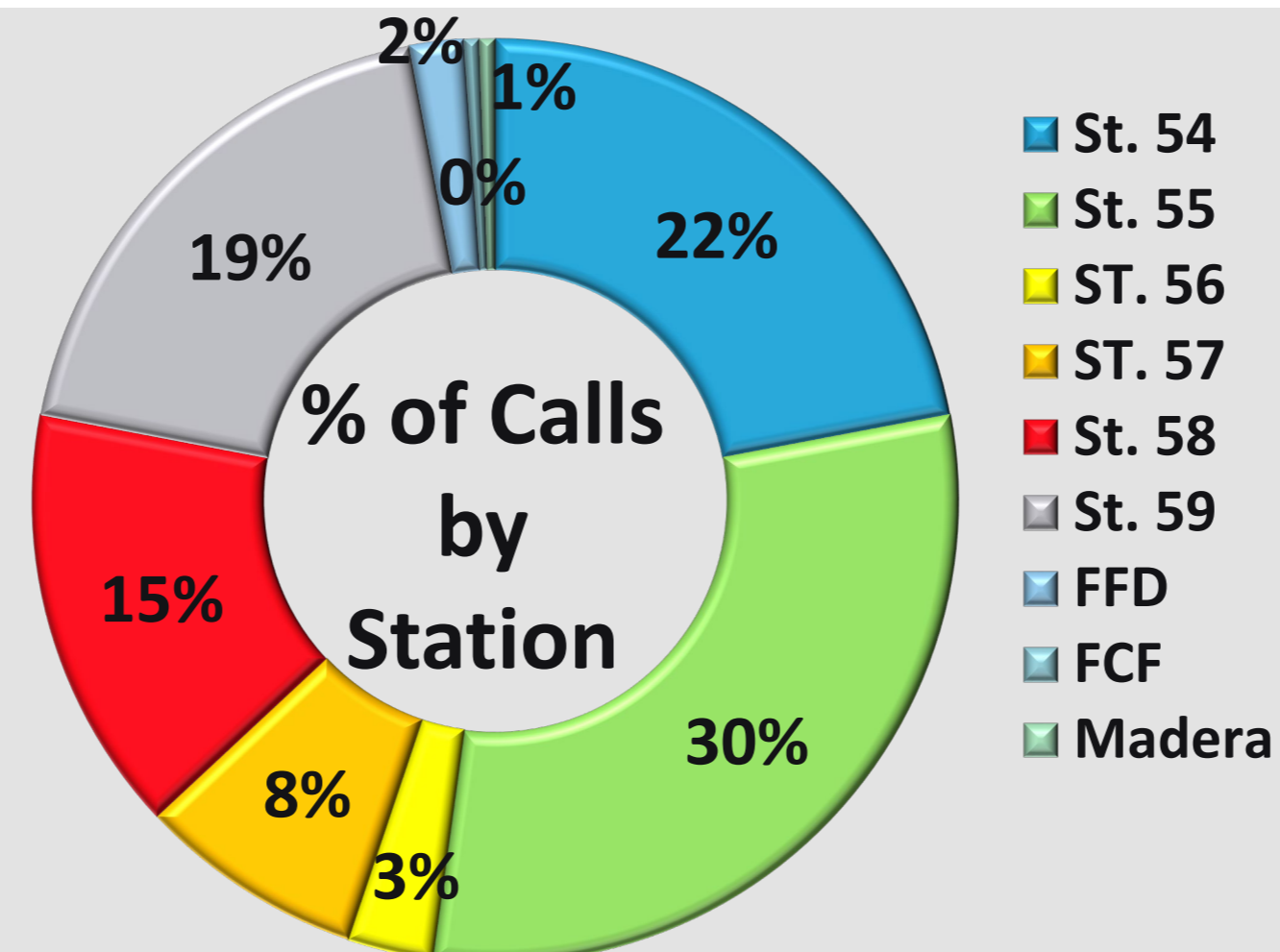

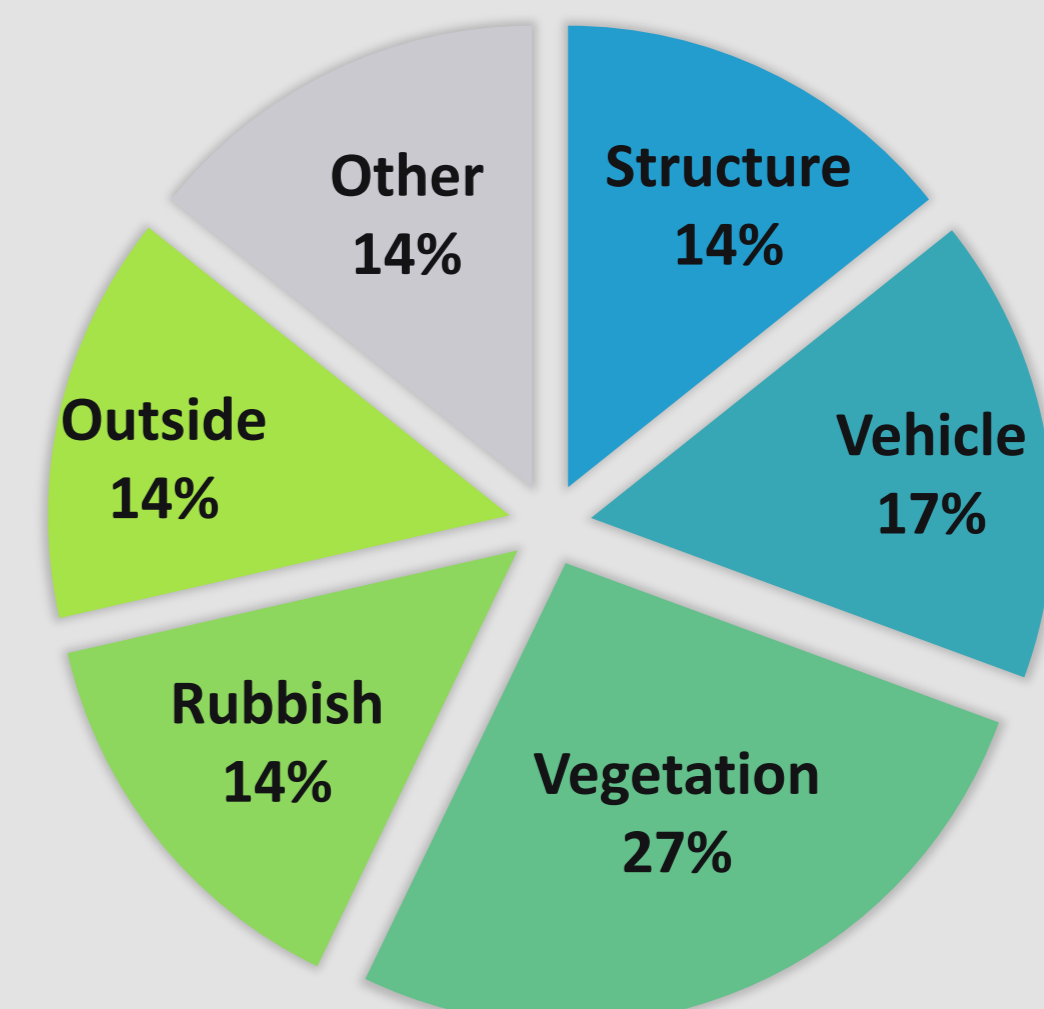
## Overlapping call % by Station (Q2)

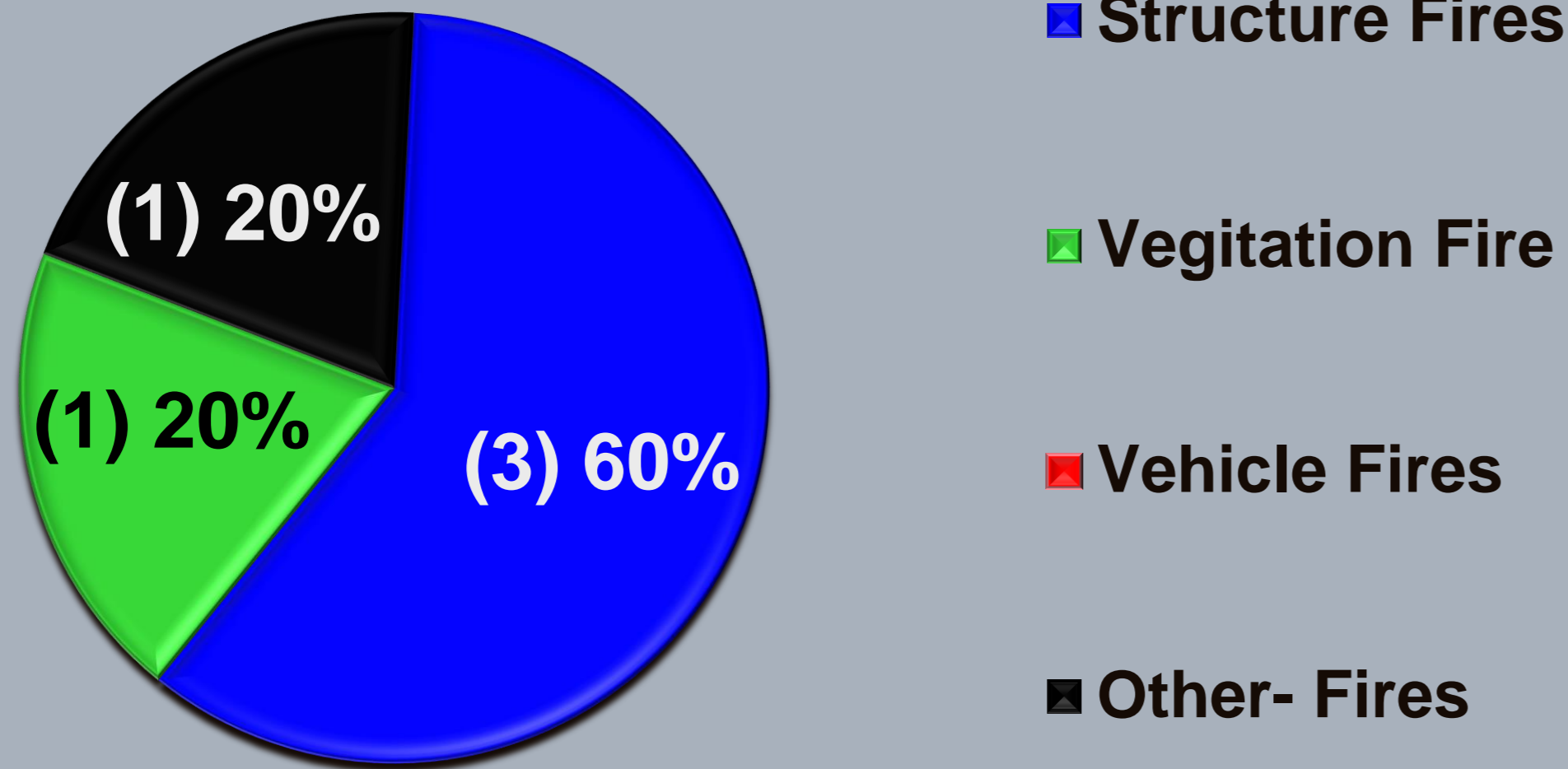

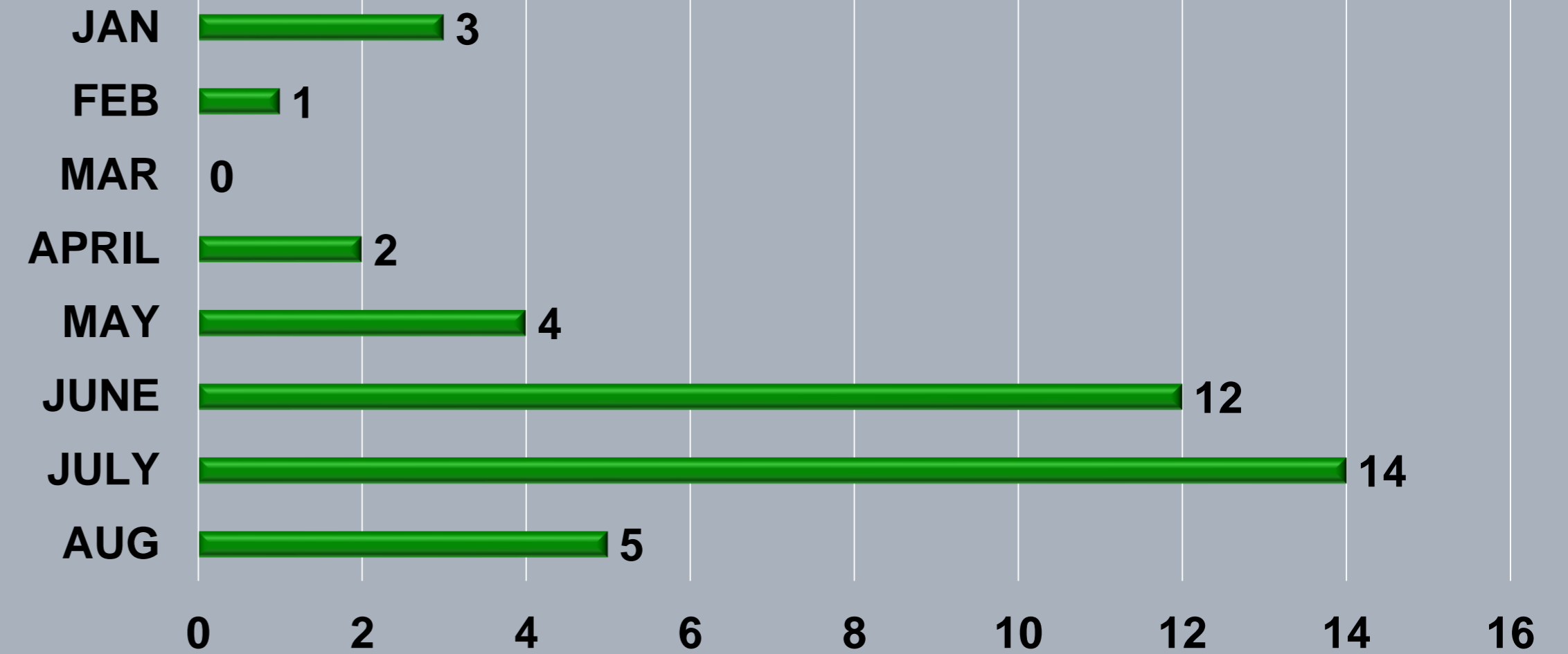

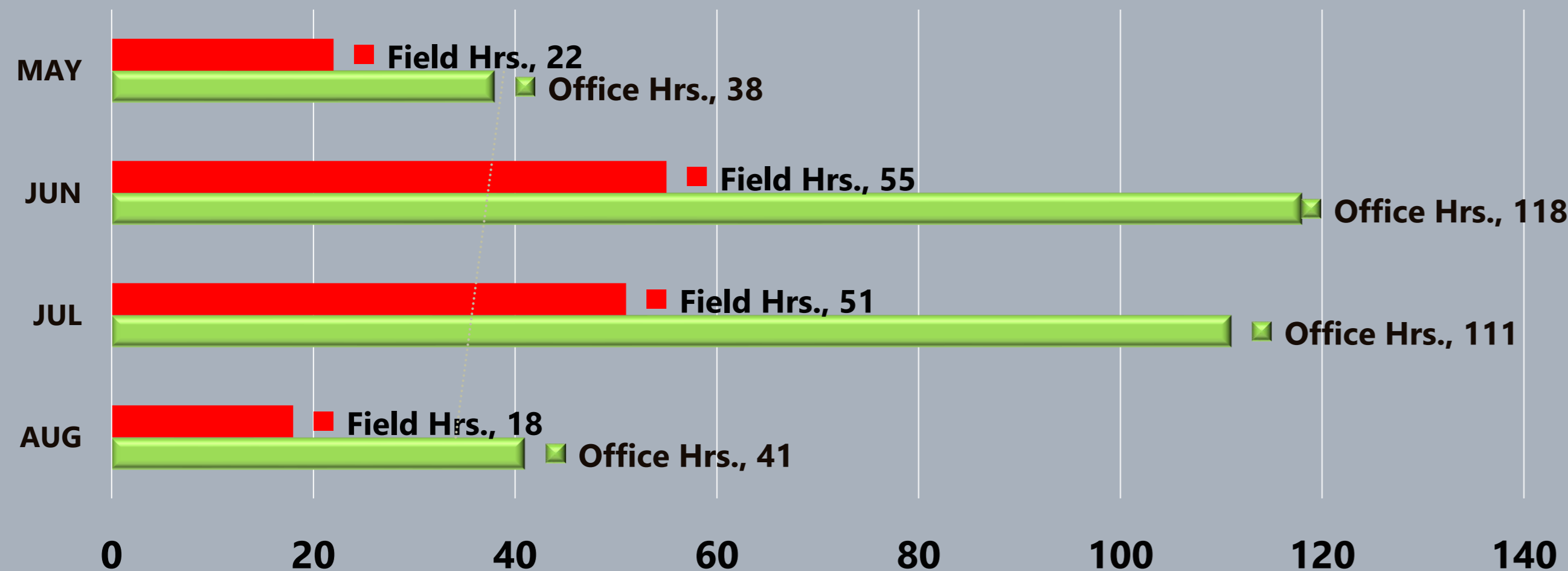
## INVESTIGATIONS BY TYPE



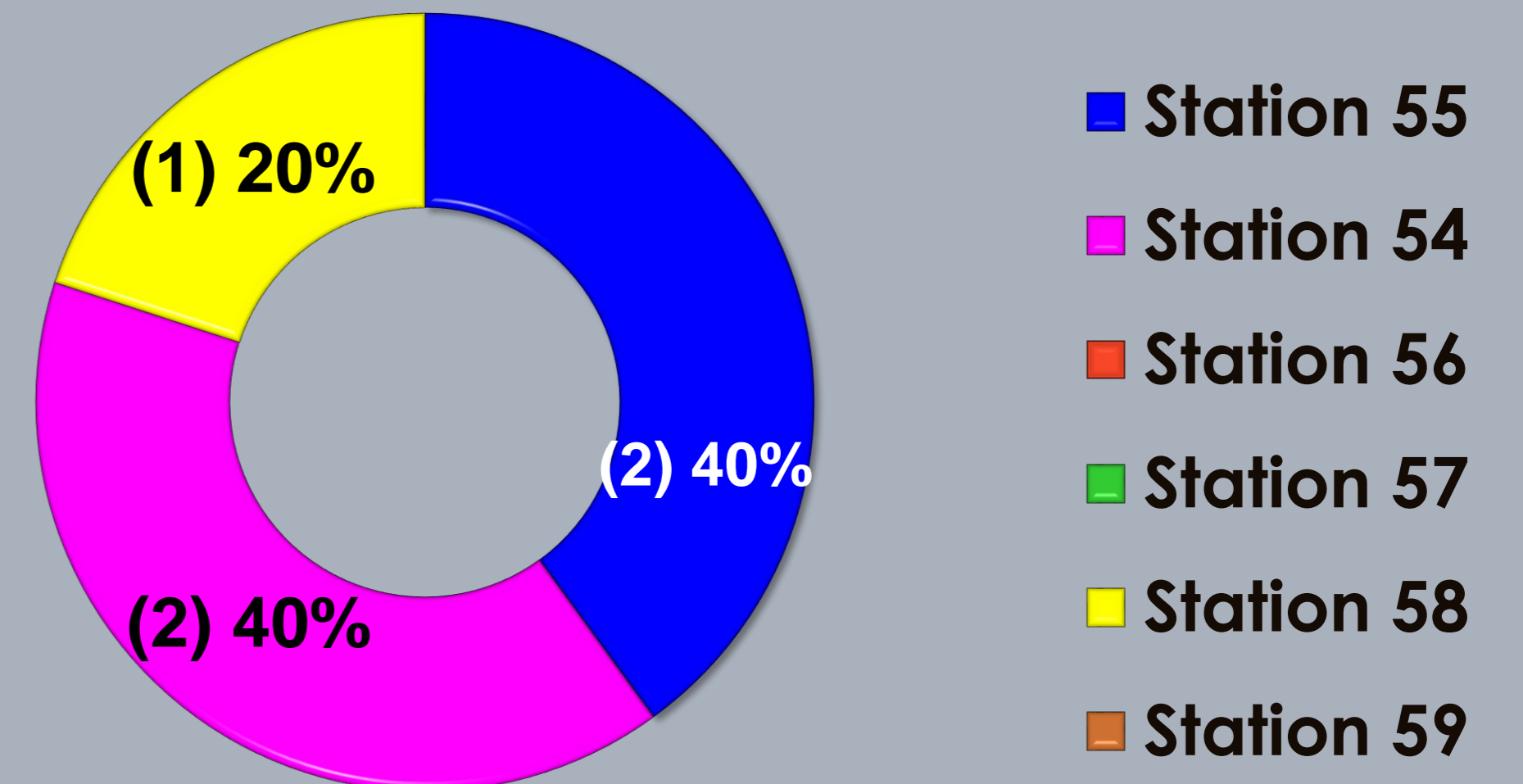
## INVESTIGATION COUNT PER MONTH



## INVESTIGATION HOURS PER MONTH

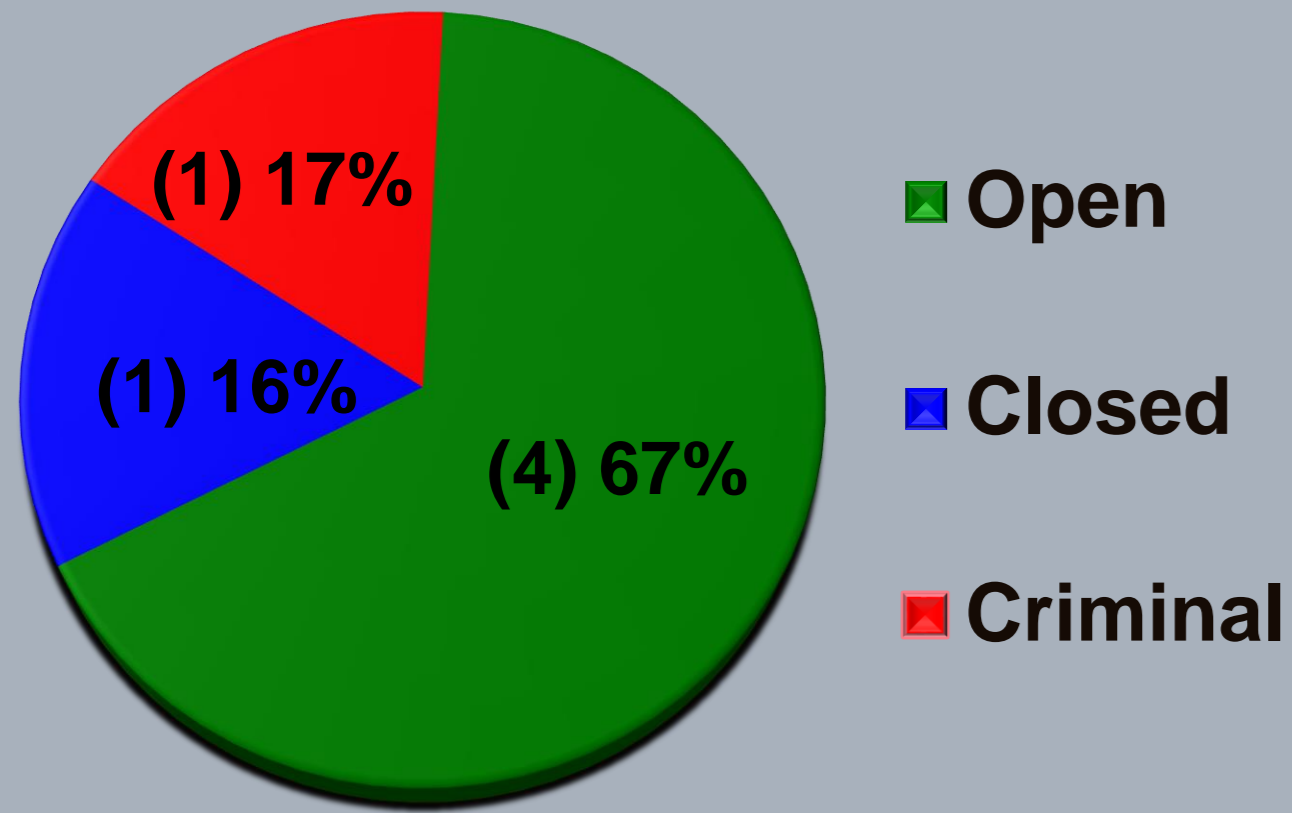

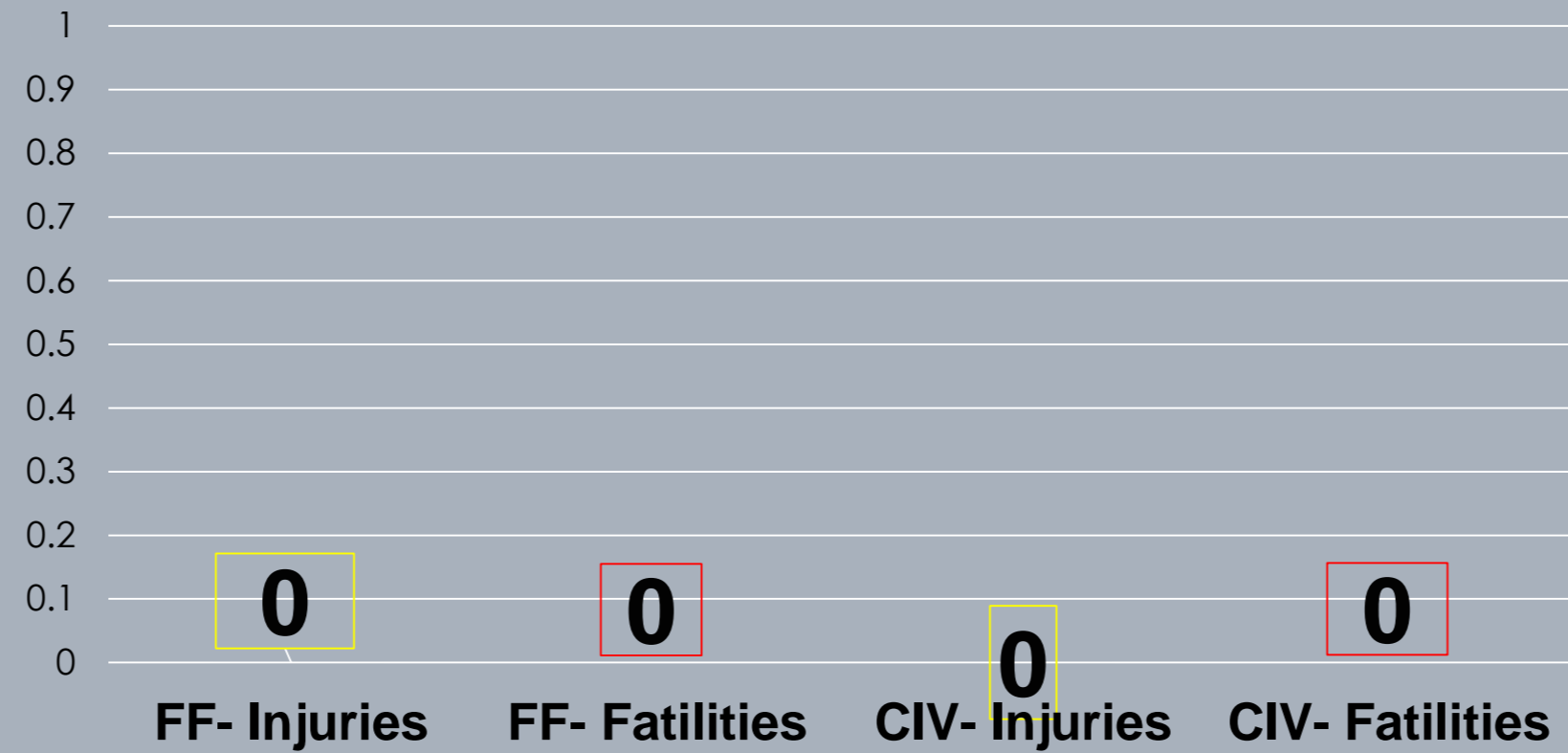

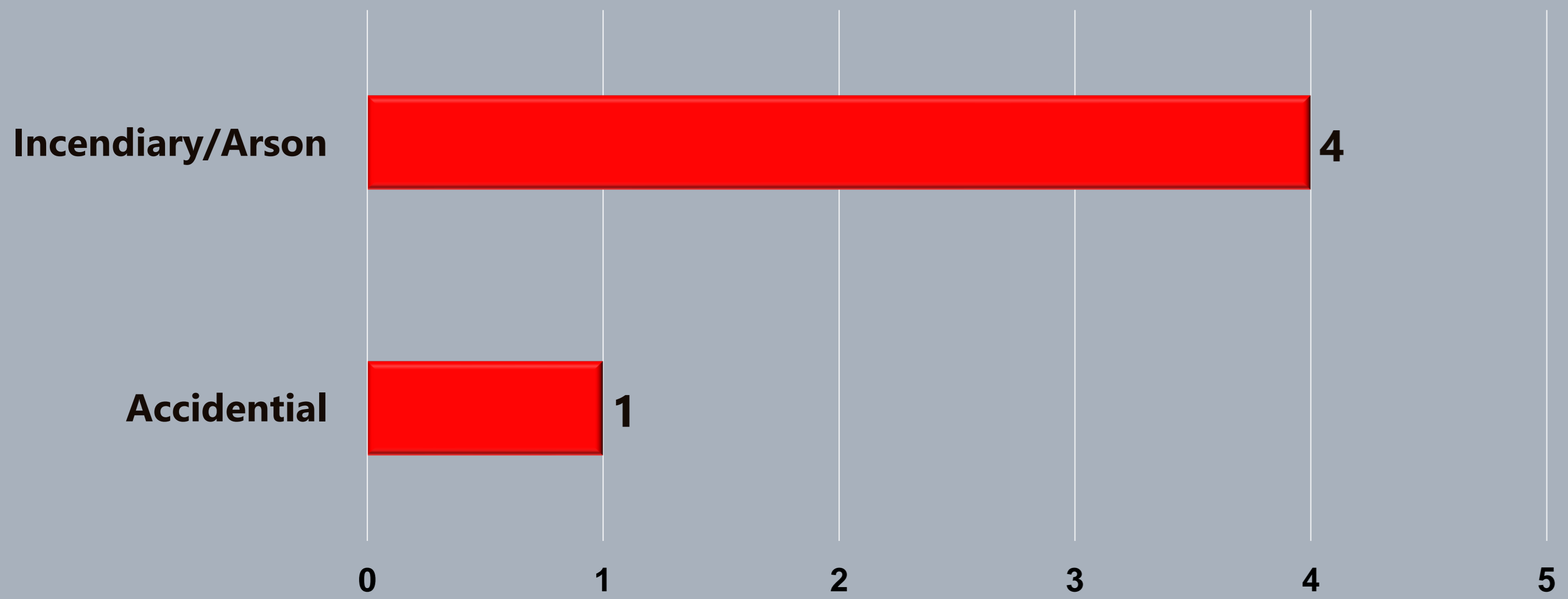

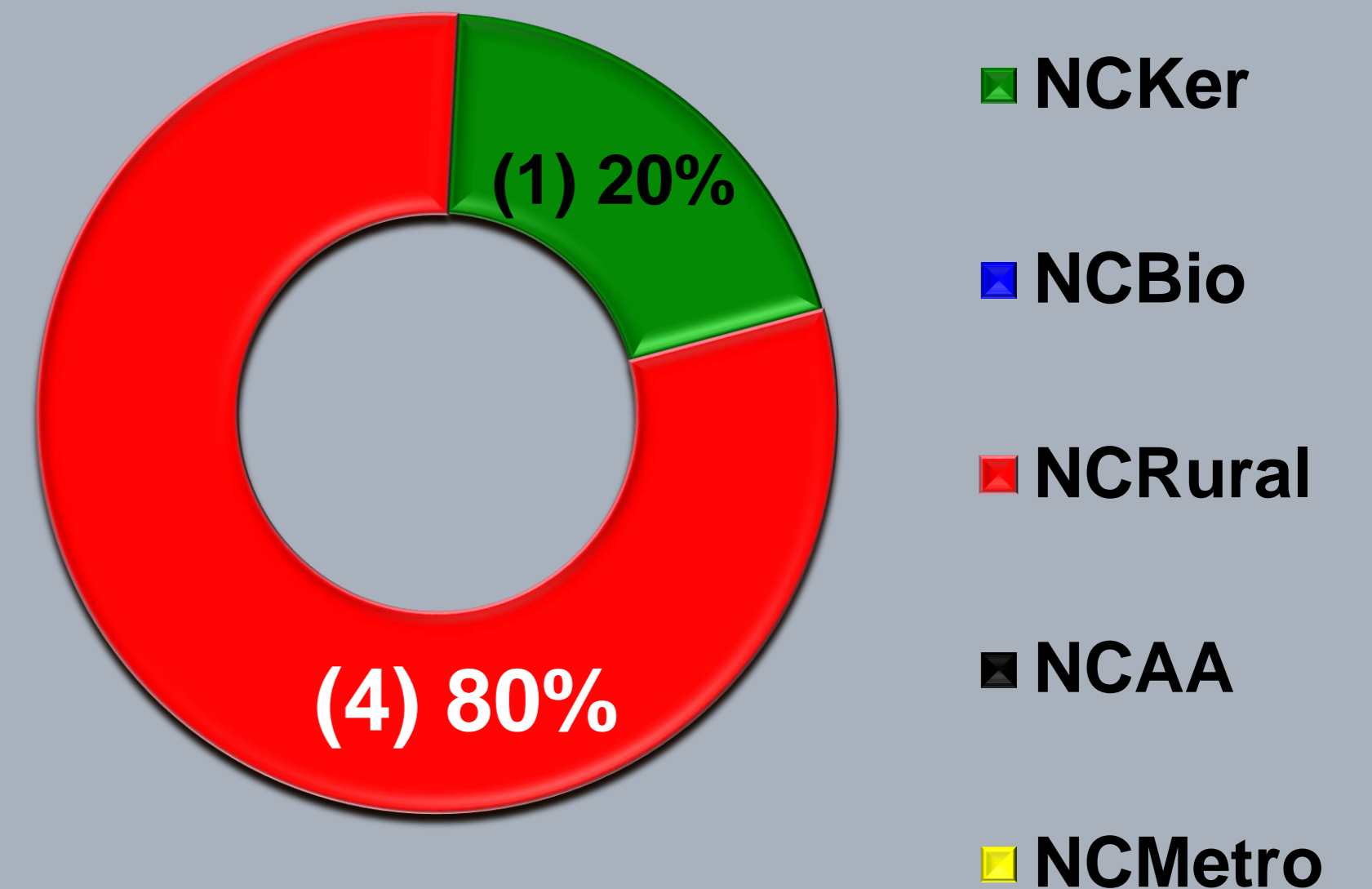
## TOTAL DOLLAR LOSS – PER MONTH

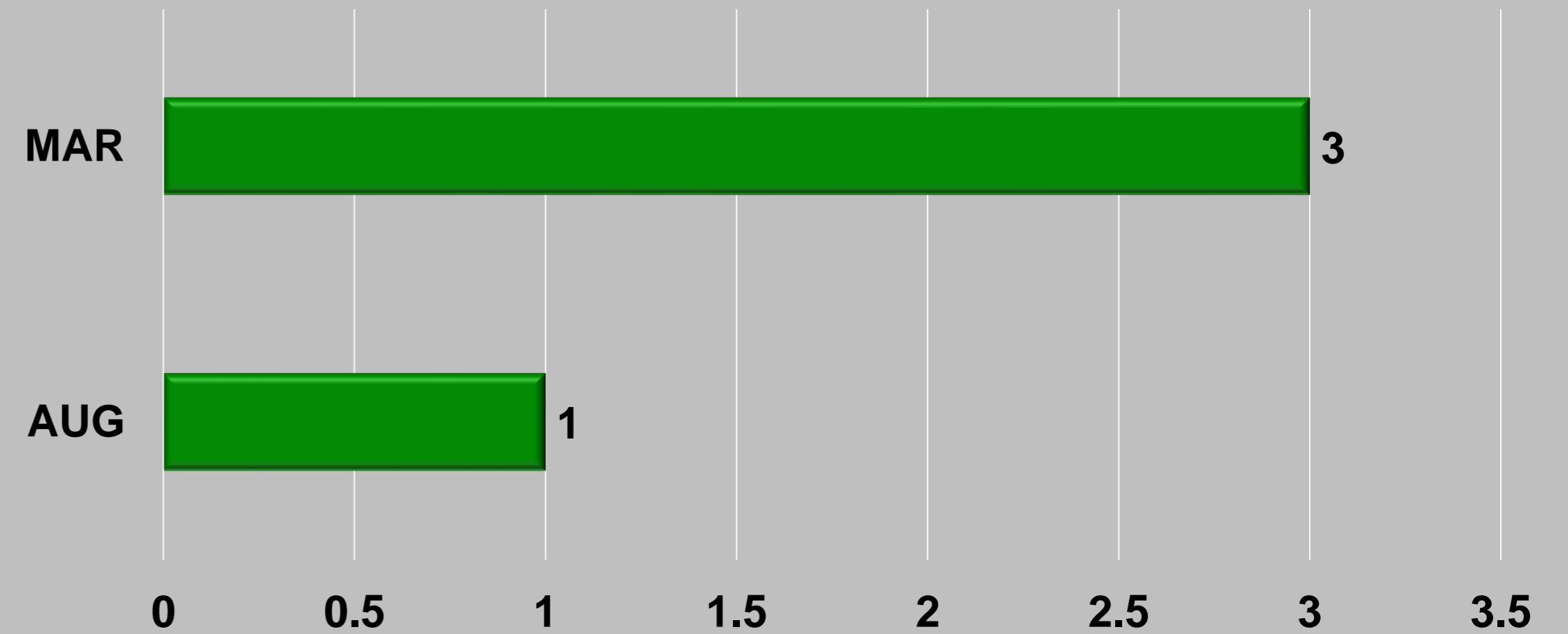

## ENFORCEMENT ACTION BY TYPE

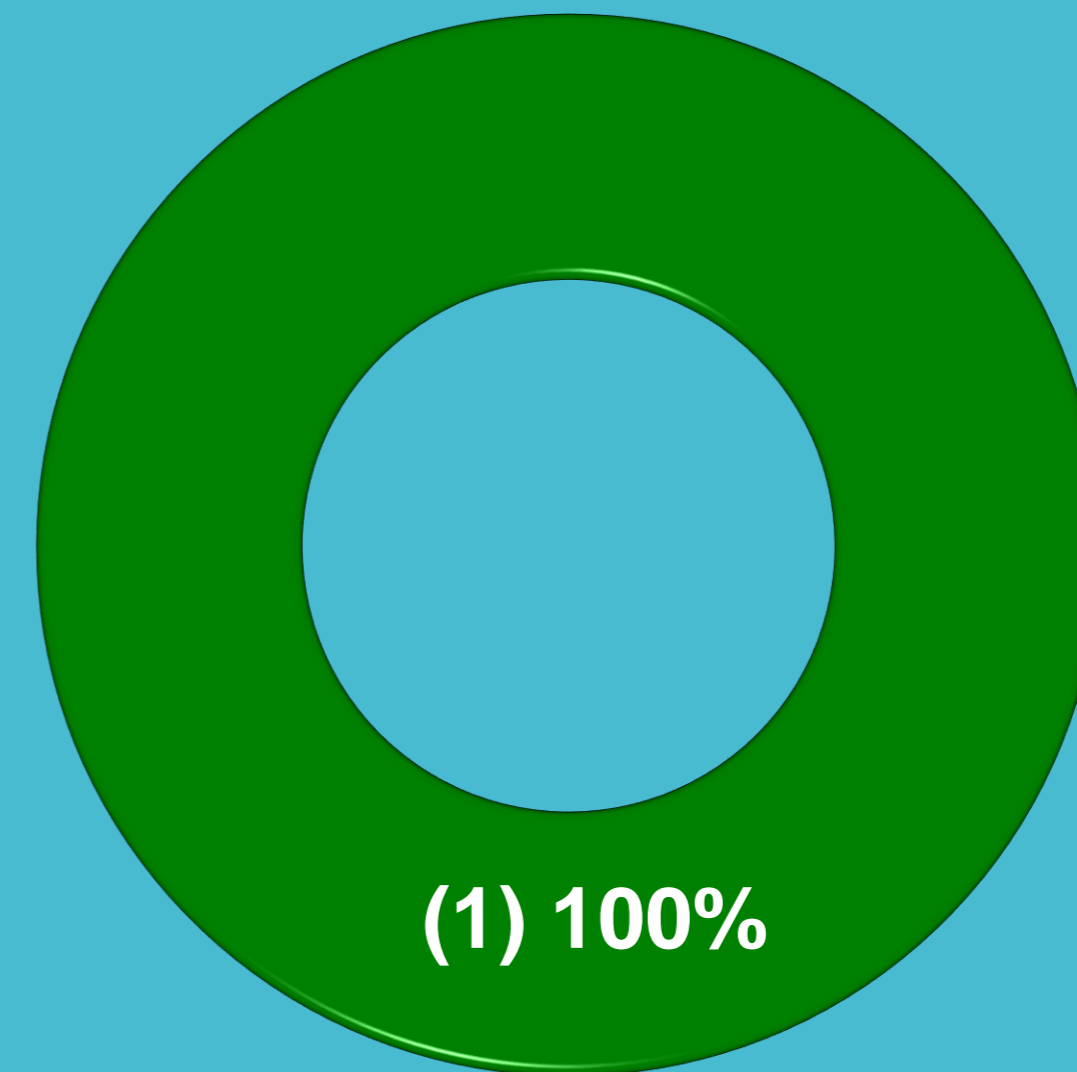

## CODE ENFORCEMENT COUNT PER MONTH 2022 YR

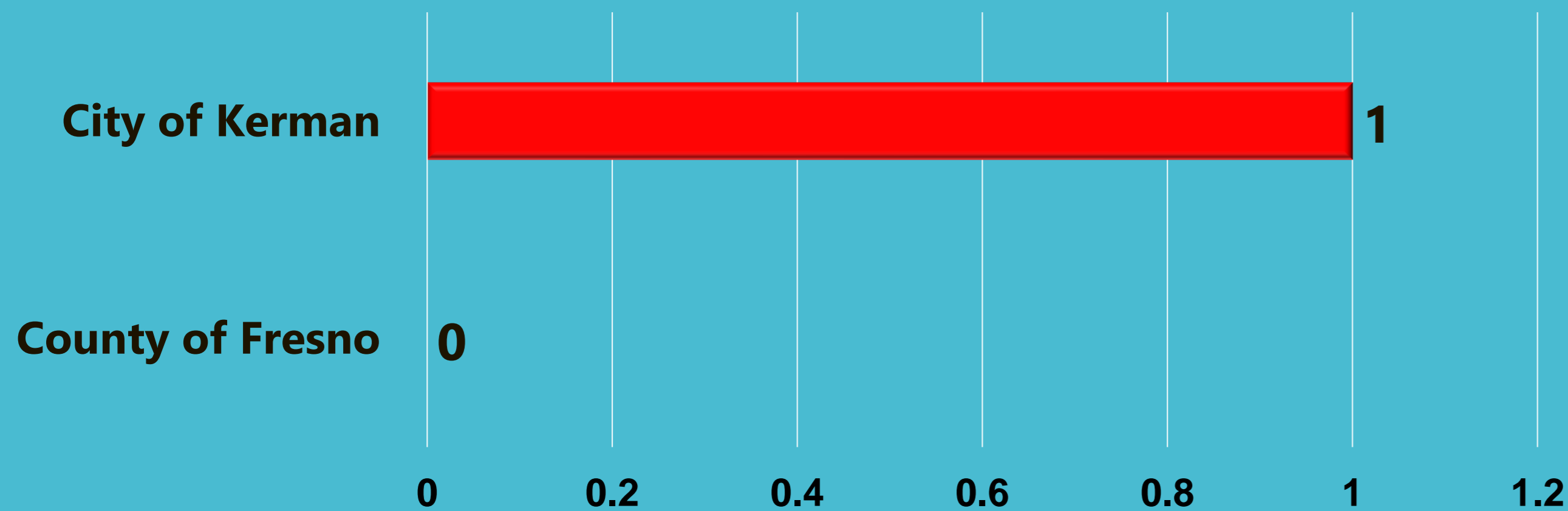


## % OF CODE ENFORCEMENT BY 1<sup>ST</sup> IN STATION

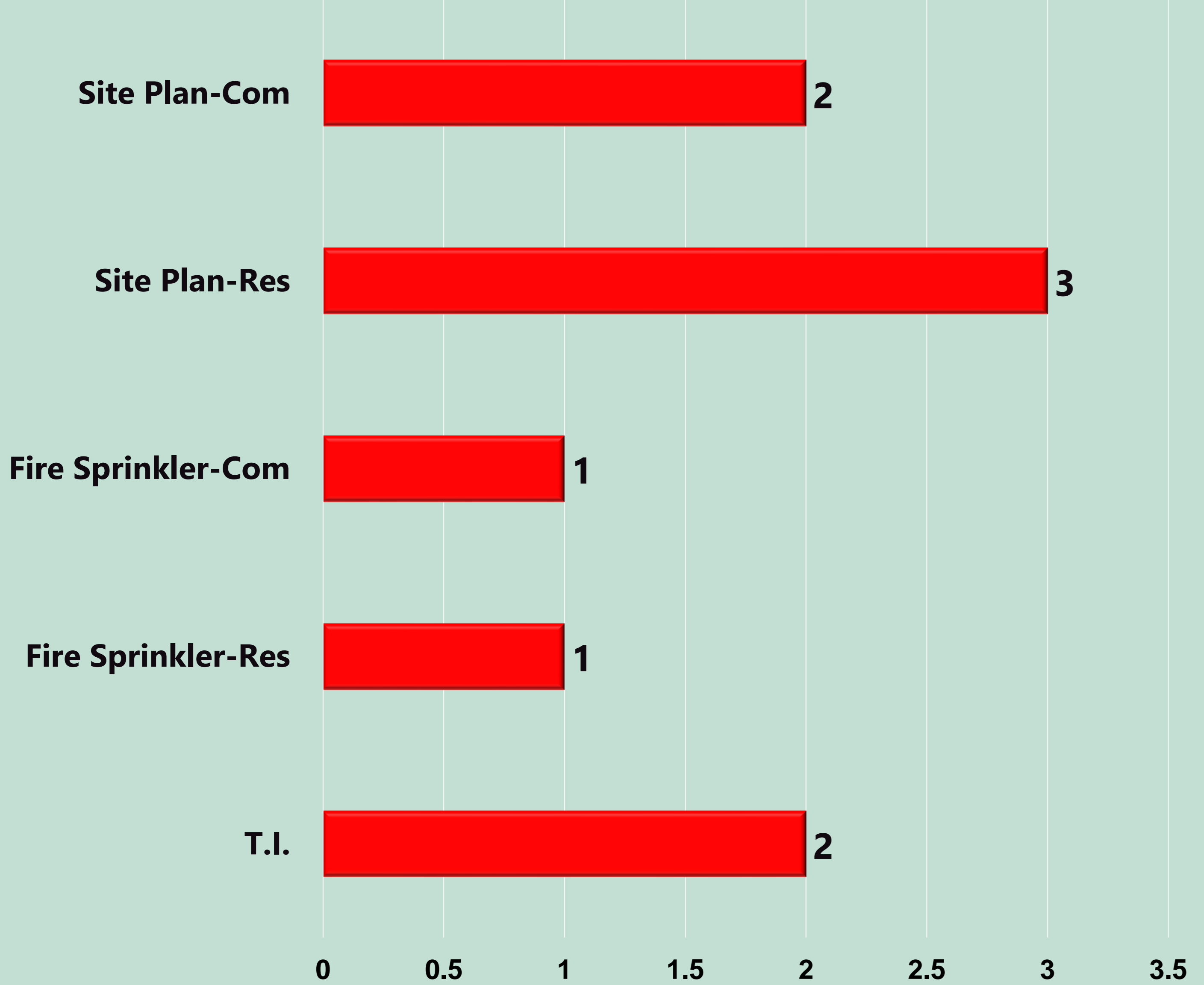

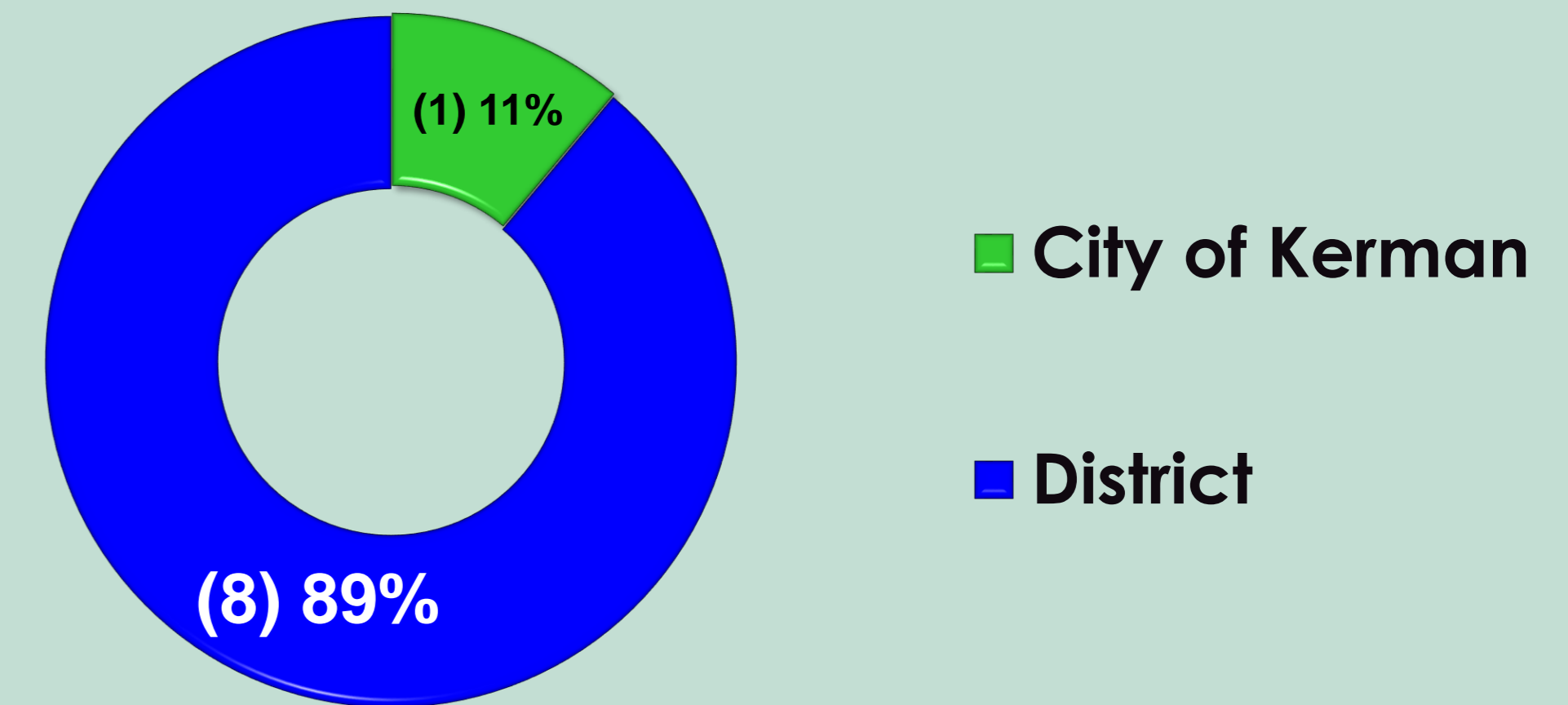
## PLANS BY TYPE

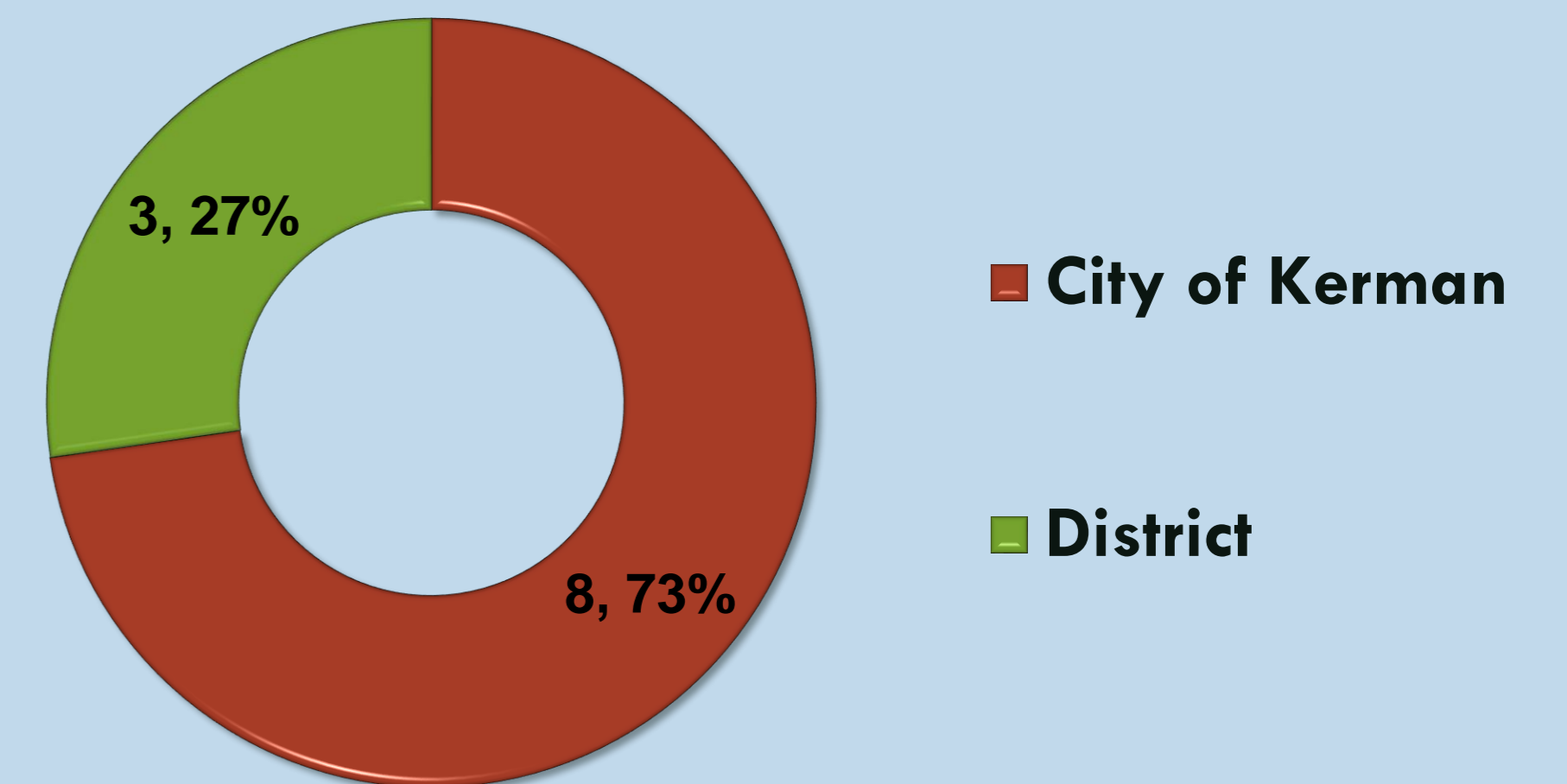
## NEW CONSTRUCTION INSPECTIONS BY TYPE

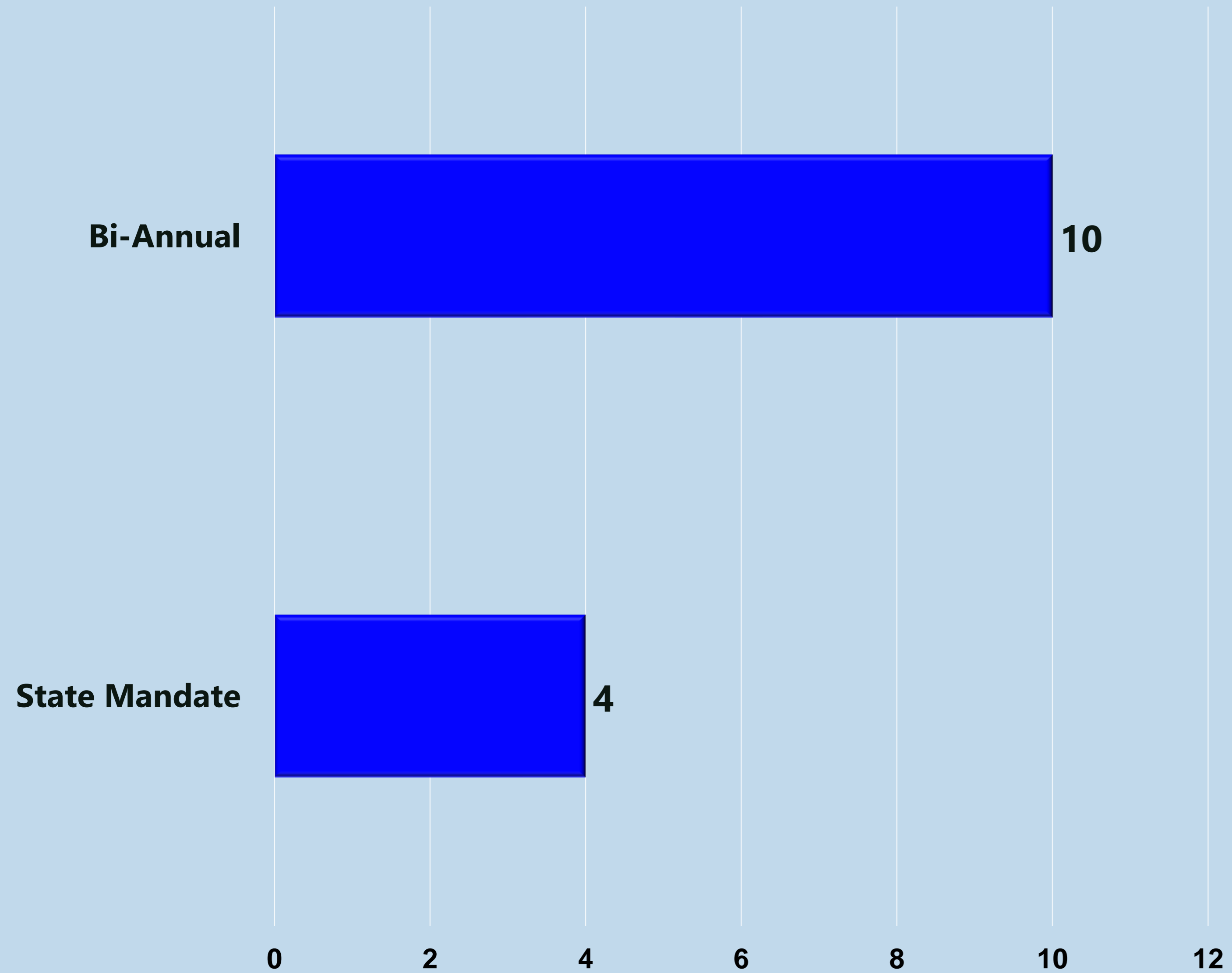

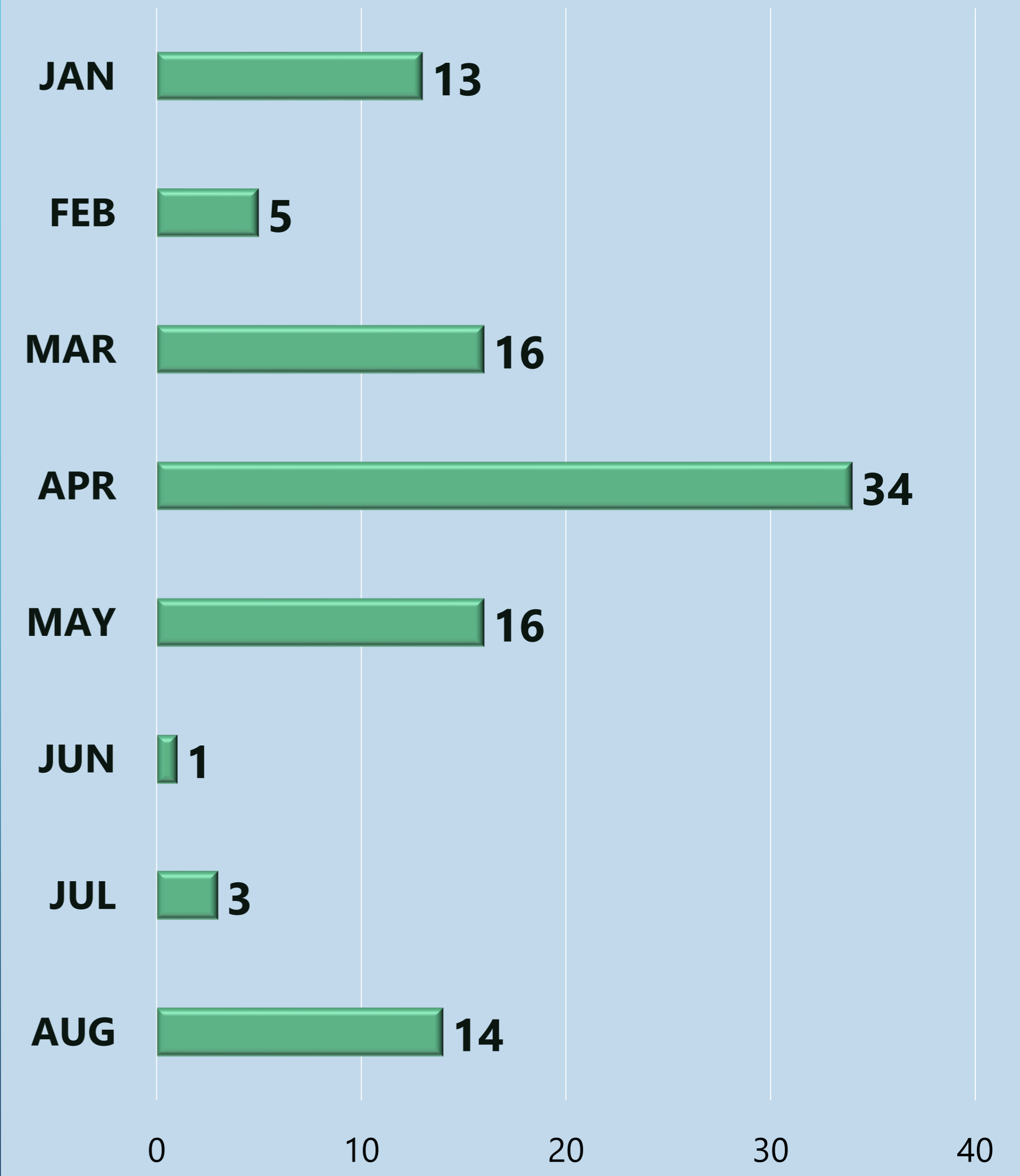

## ANNUAL & BI-ANNUAL INSPECTIONS BY CATEGORY



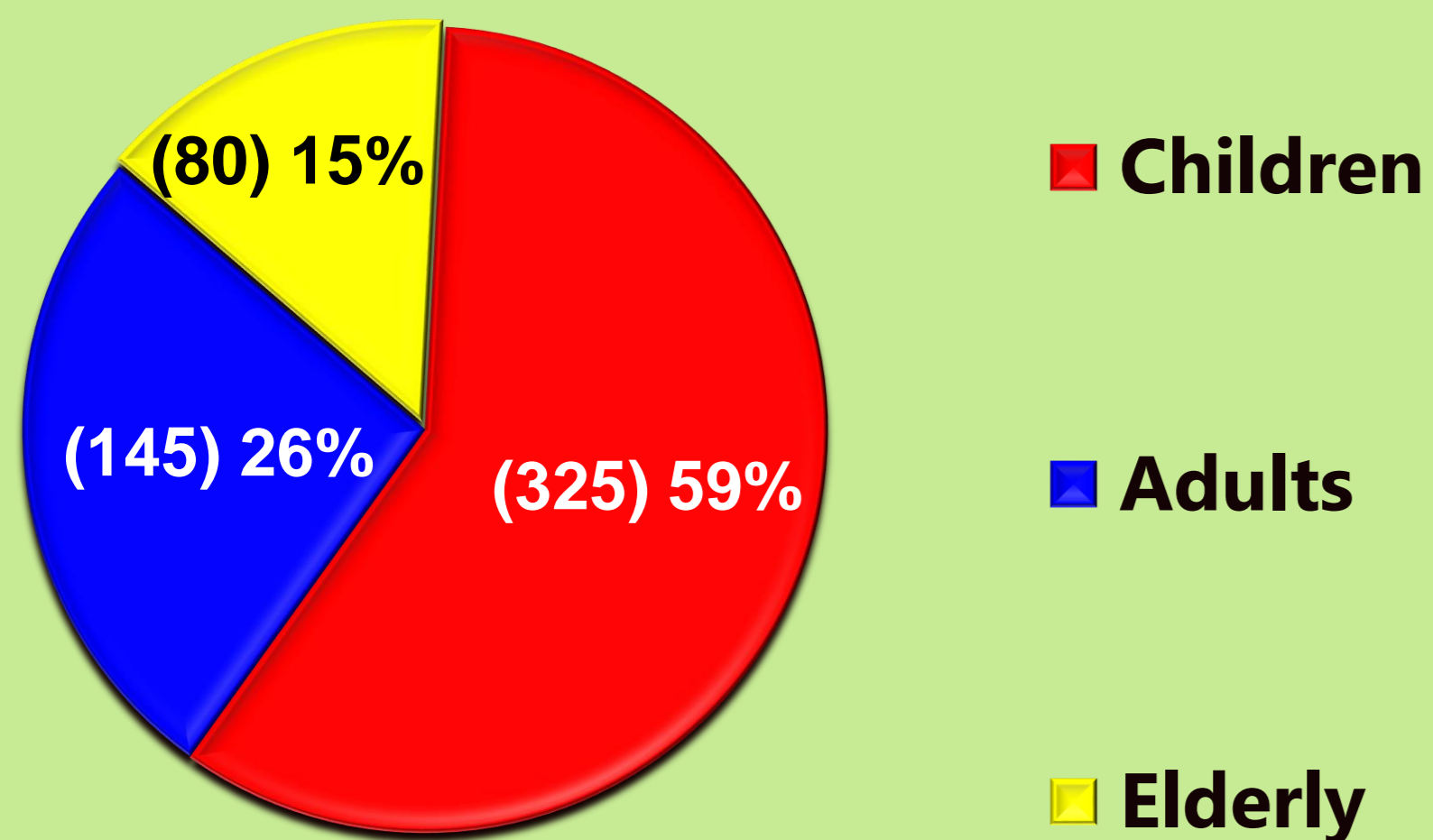
## ANNUAL & BI-ANNUAL INSPECTIONS COMPLETED PER MONTH



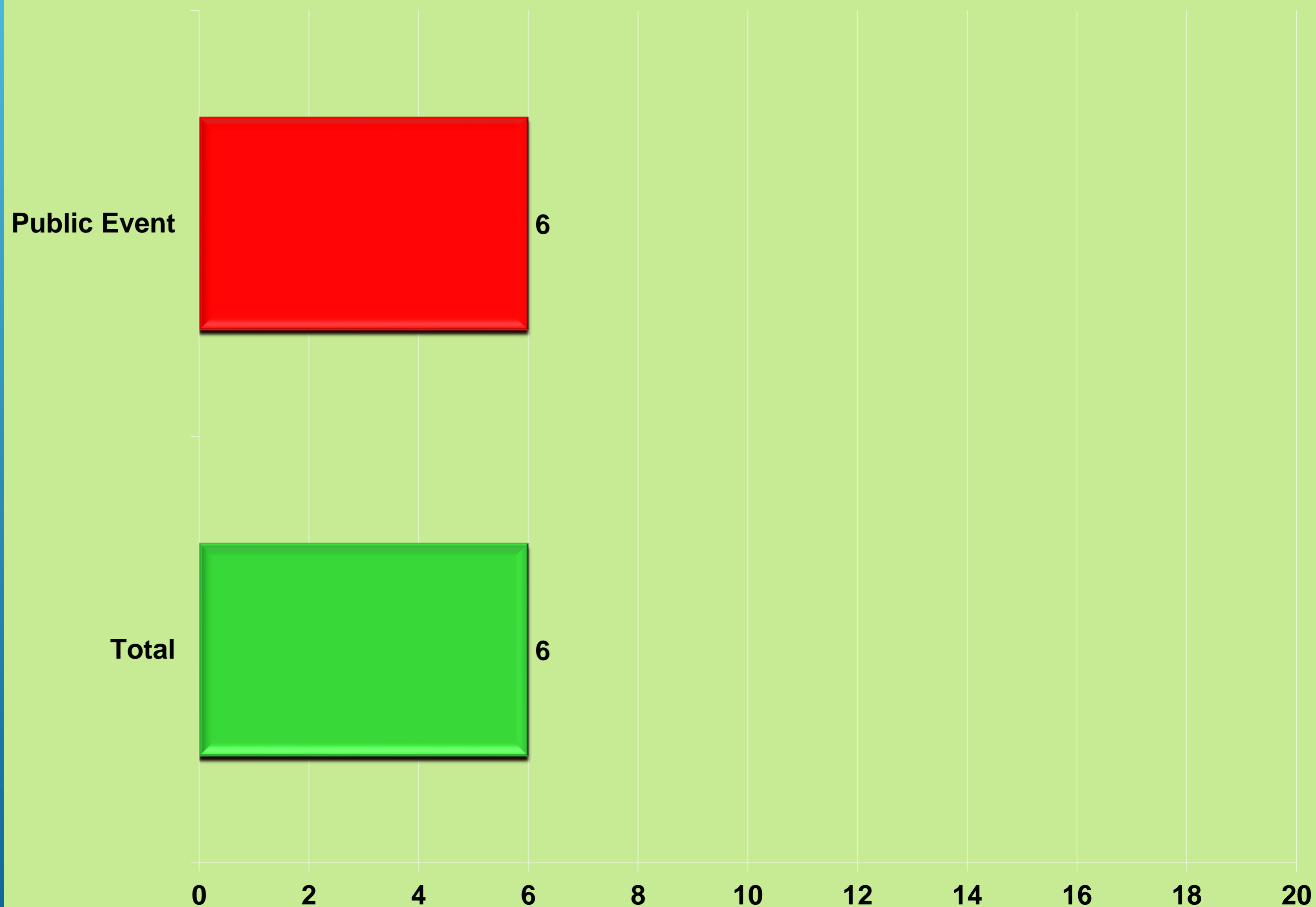
